## SECTION 4 – FIRST AID MEASURES

## SECTION 5 – FIRE FIGHTING MEASURES

<b>Fire and Explosion Hazards</b>	Non flammable liquid. However, on evaporation of the aqueous component, the residual material may burn.

As a water based product, if spilt on electrical equipment the product will cause short-circuits. If possible contain the spill. Place inert absorbent material onto spillage. ## SECTION 7 – HANDLING AND STORAGE

<b>Handling</b>	Avoid skin or eye contact with concentrate. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with soap and water after handling. Work clothes should be laundered. Launder contaminated clothing before re-use.
<b>Storage</b>	Store in a cool, dry, well-ventilated area, out of direct sunlight. Protect from freezing. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.
